I understand and acknowledge that the editors, publishers, and owners of any *Trend Dynamics publication(s)* are not in any way commodity trading advisors (CTAs). I hold the editors, publishers, and owners of Trend Dynamics, Inc., harmless for any losses I may incur trading in the futures, stock, options or cash markets. I understand that in making any investment or undertaking any futures trading I do so without relying on advice from others, and I am fully aware that I stand to lose any money so invested.

Further, in view of the difficulty of assessing damages in copyright infringement cases, I agree to pay the sum of Two hundred and fifty thousand dollars (US \$250,000) in liquidated damages to Trend Dynamics, inc., for each such instance of violation of this Agreement, and I agree to pay in addition all legal fees incurred by Trend Dynamics, Inc., in enforcing this Agreement.

Furthermore, I understand that I am not entitled to any refunds or credits for any and all Trend Dynamic publications which I have received or purchased.
